Terms and Conditions

NO PURCHASE NECESSARY. MAKING A PURCHASE WILL NOT IMPROVE CHANCES OF WINNING. Only valid for USA residents and persons legally entitled to reside in the USA and territories. To enter, visit www.uniservity.com/london (the "Website"), for a chance to win a trip to London, England for 2 persons, including a pair of roundtrip airline tickets (2 tickets) in Economy class on American Airlines from any USA airport with a scheduled direct (nonstop) service to London Heathrow Airport or London Gatwick. As of 27 June 2008, the US cities with scheduled direct (nonstop) flights to London, England are: Boston, Chicago, Dallas/Fort Worth, Los Angeles, Miami, New York and Raleigh Durham. The winner may select a pair of roundtrip (2 tickets) tickets from one of the scheduled American Airlines direct (nonstop routes) to London on the scheduled trip dates, departing the USA on Monday 12th January 2009 and returning on Friday January 16th January 2009. The trip also includes 3 nights accommodation at the London Tara Hotel, Kensington, London. A twin room (2 beds) or a double bed (one bed) will be available for the winners to choose in advance. Please note: bed sizes in England are generally smaller than in the USA. Full English Breakfast will be provided for each guest for each night's stay at the hotel (3 nights and 3 breakfasts are included for each guest). Accommodation will be taken on Tuesday 13th, Wednesday 14th and Thursday 15th January 2009. The trip also includes a pre-booked taxi transfer to and from London Heathrow or London Gatwick Airport connecting with the American Airlines flight to/from the USA. The winners will be included as guests of UniServity (the "Sponsor") at an International Networking Educational dinner to be held in London on the night of Tuesday 13th January. Dinner and beverages will be provided as per a fixed choice menu. Complimentary entry will be provided for the winners to the BETT Show, London on Tuesday 14th January. The winners will receive tickets (2 tickets) for a scheduled double-deck bus sightseeing tour of London on Thursday 15th January. The trip is valued at \$6,000 (US Dollars) for 2 persons.
